Measuring will take place near the check-in table prior to the first class.. All dogs jumping below the 22 inch Regular height or the 20 inch Select height must have a UKI measurement. The 10th Edition of the rule book has new regulations on measuring. Please see page 26, section 4.5 on Measuring Dogs. The following dogs are showing as requiring a measurement:

Parking/Crating

Crating is in the green building only. All parking is first come first served. Parking is in 2 areas; the first area is front of the red building 3 rows will fit here. There is no parking in front of these 3 rows or in front of the sheep pens. You may also park to the side of the green building in the old outdoor ring. There will be RV's coming in the afternoon. There will be cones out blocking those spots. Please do not move any cones or park in front of any cones.

Site Information

Orchard Hills is located on private property and is NOT open to the public outside of trial hours. DO NOT arrive at the trial site prior to stated times. Waiting in the driveway or on Church Street is not allowed. If you find yourself arriving early, there is a Turkey Hill and Wawa North on 100 and a Redner's and Dunkin Donuts South on 100.

Music will be played during walkthroughs and lightly during running of classes.

Helpers

This is a one ring trial and helpers are not only appreciated but are necessary to conduct a smooth running show. Please see us if you are able to help. We will have snacks and water available.

Course Maps, Gate Sheets and Real Time Results

All course maps other than Masters Series will be available 3 hours prior to the site opening time.

In an attempt to cut down on areas of congestion, we will be utilizing the Agility Gate app, developed by Roger Ly. This app can be downloaded and used on both android and IOS devices. The app allows you to check in or scratch from your device. You can also check to see which dog is currently running. You can download the app from your appropriate app store.

Online Results

All clear round/ qualifying results will be available to view within 2 weeks of the trial. You will be able to log on to your account and see results that were clear rounds, gaining Level points

Not for Competition Runs

You may turn any run into an NFC run, but must declare this right before entering the ring. You may use a non audible toy (NO clickers). You may use this time for any type of training, as long as you are not abusive to your dog. The handler may use the maximum time of 60 seconds to train any piece of equipment multiple times. If a handler chooses to train their start line, the time will be started once the handler begins to walk back towards their dog once they have left him. You MUST leave the ring immediately once time is up.

We will NOT be offering an NFC Food Reward Area.
